JOSE S. ARCILLA, S.J., is assistant professor at the Ateneo de Manila University, presently on leave writing his Ph.D. dissertation for the Universidad Complutense de Madrid. He is author of *Introduction to Philippine History*. CHARLES R. BOXER was for many years Camões professor of Portuguese at King's College, University of London. He is author of numerous books on the Portuguese overseas empire, particularly in Asia, one of the most important of which is *The Christian Century in Japan*. Since his retirement from King's College, he has been visiting professor at several American universities, currently the University of Michigan. ALBERT CHAN, S.J. has specialized in the history of the Ming and early Ch'ing dynasties, and is an associate editor of the series *Monumenta Serica*. At present he is in Wah Yan College, Kowloon, Hong Kong, preparing a catalogue of the Chinese documents in the Jesuit Roman Archives. JOHN CORREIA-AFONSO, S.J., is Director of the Heras Institute of Indian History and Culture and professor at St. Xavier's College, Bombay. His principal work is *Jesuit Letters and Indian History*, which went into its second edition in 1969. JAMES S. CUMMINS is chairman of the Department of Spanish and Latin American Studies, University College, University of London. His principal publications on the Philippines are editions of *The Travels and Controversies of Friar Domingo Navarrete* and Antonio de Morga's *Sucesos de las Islas Filipinas*. NICHOLAS P. CUSHNER, S.J., was formerly chairman of the Department of History of the Ateneo de Manila. At present he is associate professor at the State University of New York, Empire State College (Buffalo). His most recent book in Philippine history was *Landed Estates in the Colonial Philippines*. MARCELINO A. FORONDA, JR., is currently chairman of the Department of History and Political Science of De la Salle University. He has published widely in Iloko history, and is currently preparing a history of Ilokos. Among his recent books is *Samtoy: Studies on Iloko History and Culture*. LOURDES RAUSA-GOMEZ is chairman of the Department of Political Science of the Ateneo de Manila University. She has taught Southeast Asian history and government, and published an extensive study of the Philippines and the Madjapahit and Sri-Vijayan empires in this journal. EDILBERTO DE JESUS received his Ph.D. from Yale University with a dissertation on the tobacco monopoly in Spanish Philippines, which he has been preparing for publication recently as fellow of the Institute of Southeast Asian Studies in Singapore. He is associate professor of business history at the Asian Institute of Management. JOHN A. LARKIN is professor of history at the State University of New York at Buffalo. His major work on the

Philippines is *The Pampangans: Colonial Society in a Philippine Province*. JOHN N. SCHUMACHER, S.J., is professor of history in the Loyola School of Theology of the Ateneo de Manila and outgoing editor of *Philippine Studies*. His principal book is *The Propaganda Movement: 1880-1895*. WILLIAM H. SCOTT is professorial lecturer in history at the University of the Philippines, Manila. He has long studied and written on the mountain peoples of northern Luzon, as may be seen most notably in his major book, *The Discovery of the Igorots*. JOSEPH S. SEBES, S.J., is professor of East Asian history at Georgetown University. His principal publication is *The Jesuits and the First Sino-Russian Treaty of Nerchinsk (1689)*. HELEN R. TUBANGUI is chairman of the Department of History of the Ateneo de Manila University. She has edited most recently *A Catalog of Filipiniana at Valladolid*.
